Note:

- 1. The above statistics include semi-finished product scrap (products deemed scrap by MRB before CNC processing), finished product scrap (products deemed scrap by MRB after CNC processing), outsourced supplier scrap (products scrapped during the outsourced processing), and customer return scrap (products reported by the client and confirmed as scrap by customer service).
- 2. To ensure consistency between accounts and materials, all scrapped boards of all material numbers are sent to the MRB. Upon receipt, the MRB must confirm that the corresponding ERP account exists.
- 3. The MRB will categorize the scrapped products (gold-plated boards, copper-plated boards, etc.) for subsequent recycling and processing, and will log the cause of any anomalies in the ERP system. Factory Affairs will conduct daily statistical analysis based on the scrap data in the ERP and transmit the results to each unit for improvement.
- **4.** After MRB sorting is completed, the scrap is delivered to the Management Department's scrap warehouse for weighing. A weighing receipt is printed, and the net weight is written on the scrap pallet.
- 5. The Management Department will centrally designate a designated scrap board storage area that meets requirements and is managed by a dedicated person.
- 6. Dingying maintains confidentiality regarding PCB circuit information and scrap boards. If the customer requires confidentiality, the Management Department will shred the scrap boards within the factory before handing them over to a scrap board recycling company. Other scrap boards will be properly packaged and labeled after being collected by the Management Department and then handed over to a subcontractor for shredding.
- **7.** The Management Department will contact a designated government-registered recycling company for recycling. Copies of their operating and recycling certificates must be submitted to the Management Department for review.
- 8. The recycling company will dispatch a vehicle to transport the scrap boards from the factory for disposal. Transportation must be carried out without spillage or leakage, ensuring safe arrival at the disposal and storage location. The Environmental Safety Department will conduct regular audits.
- **9.** After the scrap boards leave the factory, dedicated personnel will complete transfer forms and other procedures on the "Hazardous Waste Management IoT System."
